Federal Emergency Management Agency National Working Group

Congress asked FEMA to establish guidelines to assist with the credentialing of all emergency response personnel within the United States. FEMA contracted with Cabazon Group to help create a national working group of experts. This group focused on making recommendations about the implementation steps, the basic guidance and the outreach efforts needed to move the nation forward, and improve the number of people qualified for interstate deployments under the National Incident Management System (NIMS). As part of our support of the working group, we performed issues analyses, drafted papers and offered draft guidelines for adoption by the group and the agency. This multi-discipline effort in intergovernmental relations successfully led to proposed guidelines of a nationwide system of qualifications, training and verification to improve the nation's preparedness and capability to respond to disasters.
